INSTALLATION MEETING **MINUTES**

PROCEDURAL ITEMS:

Mayor Doc Davis called the meeting to order at 7:00 p.m. Present for a quorum were Mayor Davis, Sarah Welch, Wayne Hester, Ralph Landreth, and Brenda Mabe. Also present were Town Clerk Lynn McKinnie, Attorney Amy Lanning, and City-County Planning Staff member Aaron King. The audience included newly-elected council members Marilyn Martin and Randy Mendenhall, who will be installed later in tonight's meeting.

The Reverend Harold Schwantes, Pastor of Morris Chapel United Methodist Church offered a brief Invocation after which, the Pledge of Allegiance was led by Council Member Ralph Landreth.

On a motion by Brenda Mabe, seconded by Wayne Hester, tonight's agenda was approved as presented.

Public Session was opened and closed at 7:03 p.m. with no speakers.

OLD BUSINESS:

ITEM #1: FOR DISCUSSION AND/OR ACTION:

ONGOING DISCUSSION OF \$100,000 RECREATION MONEY
(ATTACHMENT)

Discussion was ongoing concerning use of the money bequeathed to the town by Spencer Waggoner to be used for recreational purposes. At tonight's meeting, Brenda Mabe submitted her proposed uses for the money. She stated that Mr. Waggoner was a long-time resident of Walkertown and knew what he was doing when he willed the money to the town for a certain use – he wanted it used for recreation. Her suggestions would incorporate the use of walking trails, a gazebo, various games such as horseshoes and shuffleboard, and a place for smaller children to play. She also included a "memorial" in the form of a clock that would honor Mr. Waggoner for his donation. She stated that her plan could be improvised as things progressed but that it was a most workable solution and would fit in with the actions required by the lawsuit against us.

She said that Mr. Waggoner was a very intelligent man – he lived his life here in Walkertown. I read his will several times and never saw a time-stipulation. And Mr. Waggoner loved his hometown and he loved his schools so if he felt like they needed the money, he would have left them the money. He knew all about the organizations in Walkertown and he would have left them the money. And he loved his church, and he did leave them some money. I don't believe there's been a problem with his church money. I feel like this suit should never have come about because there's nothing based upon it. Therefore, I'm putting in a motion that we spend Mr. Waggoner's money on a town park behind town hall by hiring the firm of Alley, Williams, Carmen, and King and Ken Stafford to research grants for the park. Recently I was in Fayetteville with

some other council members and discovered a community that built a recreation facility with all grant money and to get grant money you have to have money. This proposal that I'm suggesting is not written in stone. I'm proposing that we build walking trails, benches, picnic tables with shelters, a gazebo, various games such as horseshoe pits and shuffleboard. You got to have water so we need water fountains; you got to have bathrooms, so we need those, too. Parking – we need places to park. We can upgrade rooms in the building I call the “annex” building and use for town hall meetings and, look – we don't have a meeting hall. It can also be used by the Planning Board and other groups. On certain days, the town would designate “town” days and then the other days, the citizens of Walkertown can use for other things. So this can be used as an all-purpose room. Behind the Booe-Griffith house, the yard is already fenced and would be a perfect place for a playground – with benches and a permanent hopscotch. Therefore, I would like this plan to be presented to the judge for this plan to be used for the Waggoner donation.

FINAL DEVELOPMENT PLAN

At 8:10 p.m., Aaron King spoke on the McDonald's request for approval for their Final Development Plan for the restaurant to be located at 158 and 66.

The Public Hearing was opened at 8:14 p.m. with three speakers – all requesting that the Town Council approve the plan.

(1) Harold Warner
2958 Lakawanna

Mr. Warner said he had been against the previous site for the McDonald's and Walgreens but was in favor of this new site at 158 and 66. He requested that the Council approve the plan.

(2) Enos Jumper
5028 Klondike Rd.

Mr. Jumper said he too had been against the original location but was all for this version and he requested the Council approve the plan.

(3) Peggy Leight (Chairperson of Walkertown Planning Board)
5150 Sullivantown Road

I wanted to let you know that, yes, the Planning Board approved this and I am in favor of it. I think this is the area that we rezoned specifically for business in Walkertown. Just one piece of caution is that pretty much as McDonald's goes – so goes the rest of that whole development. So, we have to be very careful – that's why we wanted to see the elevations and what it looked like. We want to make sure with the trees, that you all are satisfied with that. The lighting – everything that goes into that one spot is pretty much how the whole area is going to be developed so make that that's what we want to see for this area. Thank you.

Public Hearing was closed at 8:18 p.m.

MAYOR DAVIS: Council, what is your pleasure? If you want the site plan to include the elevation and the view as you saw it on the overhead, that should be included in the resolution or in the motion as it's made.

MR. MENDENHALL: I make a motion that we accept this as long as it's with the elevation shown and also the landscaping as per set forth by the Planning Board.

DISCUSSION BEFORE VOTE:

MR. KING: I can explain a little bit on that. When the original rezoning request was approved in 2004, there was a condition that was added to that for all the streetyard plantings – that the trees be of large variety. That condition didn't specify what variety of tree that was so when we talked with the petitioner and the developer on this, the only fair way we saw to do it was McDonald's got their first choice of whichever large variety tree they wanted and when other parcels develop, they have to match what McDonald's puts in. So the petitioner has specified on site plan that it's a type of elm tree that will be planted there (Alley Lace Bark Elm) so it's specified on the site plan so that's what you would be getting out on the site and that's what you would be getting for the rest of the outparcels.

MAYOR: So you're saying this is a game of semantics – are you saying the large variety is according to size and not to number or types of trees, is that what you're telling me?

MR. KING: It's based on size.

MAYOR: It's based on "*large in size*". Would you tell the council what that means?

MR. KING: I believe it's 8 to 10 feet in height and there's a certain caliper(?) – I'm not sure what size.

JESSE LESTER: As far as the elm tree variety, this species of tree is very disease resistant. It probably gets 55 to 60 feet at full maturation – 30-feet in width. By "large variety" I think it means that at time of installation, they have to be a minimum of 8- to 10-feet with a 2- to 2 ½ - inch caliper when they're planted to ensure that they will survive the first year or two after they are planted. This is just for the street yard and will be the tree that lines the streetyards to pull unity with the private streets. There would be also a streetyard requirement of a continuous

row of shrubs in conjunction with those trees. And then, of course, the internal site plans for each outparcel would probably have their own different species.

MR. KING: There was a condition that all the **internal roads** that the developer will be constructing have **sidewalks on both sides of those roads**. So as these outparcels come in, we'll be looking for those sidewalks on whichever frontage the outparcel has – in this case, there's frontage on two sides of those internal roads. That's what the developer will be required to construct. As each of the other ones come in, they'll have to do their part of it as well.

MAYOR: But, there'll be no sidewalks on the 158 side?

MR. KING: No.

MAYOR: And that's with curb and guttering?

MR. KING: Yes.

MR. HESTER: I think McDonald's did a good job in meeting all the requirements that were presented to them and I feel it's a good project and feel we should vote on it.

MAYOR: Aaron, to make sure Council is aware of the upcoming sign ordinance that we've already reviewed that will be discussed in February. These will conform to the ordinances, is that correct?

MR. KING: Correct. What we had discussed in the revised sign ordinance was for a typical outparcel of standard sign height of 6-feet with a copy area of 36-square feet. For a point of reference, that is what the signs that have gone in on the Sheetz, the Wendy's ---- that's what kind of sign you're looking at. And there was an original condition of approval for this site, that same specification so the sign that will be constructed will be in conformance with what we'll be talking about in a couple of months.

DISCUSSION:

MR. HESTER: I had spoken with D.O.T. before about this and the speed limit on 158 had been 55-mph for 50 or 60 years – and that was long before the congestion, all of the building that's going on in that intersection. I want to make a motion that we pass a resolution to send a letter to D.O.T. **requesting that they reduce the speed to 45mph going west on 158 about 200 yards before getting to Belews Creek Road. After passing Belews Creek Road (east of Belews Creek Road 200-yards) that they reduce speed limit to 35-mph through the intersection. Then, going west past the shopping center, that it stay at 45-mph instead of going back to 55-mph. And, then reverse that coming east on 158 – reduce the speed to 45-mph, before they get to the Texas station (Darrow Road) and 200-yards past that, going east on 158, reduce it to 35-mph through the intersection. Then on the other side of 66 and 158, change the speed back to 45-mph 200-yards past that area.** Also, we need to request that they reduce the speed on **66 – coming from 158 to Darrow Road** to perhaps **35-mph**. So I would like to make a motion that we pass a resolution and send a letter to the D.O.T. requesting these speed changes. And all we can do is request to them – we can't demand!

MOTION: TO REQUEST THAT THE NC-DOT MAKE THE FOLLOWING SPEED LIMIT CHANGES:

- REDUCE THE SPEED TO 45MPH GOING WEST ON 158 ABOUT 200 YARDS BEFORE GETTING TO BELEWS CREEK ROAD

- AFTER PASSING BELEWS CREEK ROAD (EAST OF BELEWS CREEK ROAD 200-YARDS) REDUCE SPEED LIMIT TO 35-MPH THROUGH THE INTERSECTION.
- GOING WEST PAST THE SHOPPING CENTER, SPEED LIMIT SHOULD STAY AT 45-MPH .
- REDUCE THE SPEED TO 45-MPH COMING EAST ON 158, BEFORE THEY GET TO THE TEXAS STATION (DARROW ROAD)
- 200-YARDS PAST DARROW ROAD, GOING EAST ON 158, REDUCE SPEED LIMIT TO 35-MPH THROUGH THE INTERSECTION.

BEFORE THE VOTE:

MAYOR: Is everyone clear on all his reductions and changes? I'm sure most people could tell from Belews Creek to Darrow Road – where he's coming up and coming back on both sides is what he was referring to – from 45 mph to 35 mph....and then back to 45 mph – and then flopping on the other side, coming back north on the northbound lane to the 45 mph, and then back to 35 mph through the intersection. And the resolution would request to change the speed limit from 158/66 crossing to Darrow Road to 35 mph. I don't know why it couldn't be that to **Harley Drive** but I think you said Darrow Road only, so that's good.

MR. HESTER: Well, I had a request for Darrow but I would change that to Harley Drive, definitely.

MAYOR: Well, it's up to Council. Who seconded that?

MR. HESTER: I would re-word the resolution to make it to Harley Drive. Would that be all right with the second??

MS. MARTIN: That would be fine with me!

MAYOR: All right. So that would mean **the resolution would ask the D.O.T. to change the speed limit on Old Hollow Road from Highway 66-158 intersection to Harley Drive to 35 mph from 45 mph.**

MOTION: TO REQUEST THAT THE NC-DOT MAKE THE FOLLOWING SPEED LIMIT CHANGES:

DISCUSSION:

MAYOR: If I read this correctly, the cost is \$205,000, Ms. McKinnie?
LYNN: Mayor, I am not sure that this is the correct worksheet for the Town of Walkertown. I think he sent me the wrong sheet. I had asked him for something to include in our agenda packet that would break down the costs.....
MAYOR: So what D.O.T. is asking us to do is pay 10% of the cost of that? Is that correct?
LYNN: Yes. And it will be right around that amount – I don't know if Frank sent this worksheet as an example of what would be required – or if he got confused and sent it because he noticed "Wilmington" on the paper and just immediately thought we were in Wilmington, North Caroline ---- even though it plainly states, "Wilmington – New Hanover County. Anyway, I think we better wait on this and let me give him a call and find out.....
MAYOR:I think probably in the best interest of us and the public as well, let's get the correct one and postpone this. Is that okay with council?

ON A MOTION BY WAYNE HESTER, SECONDED BY SARAH WELCH, AND UNANIMOUSLY APPROVED, THIS ITEM – TO UPGRADE RAILROAD CROSSING – WAS TABLED UNTIL LYNN SUPPLIES CORRECTED INFORMATION.

MS. MARTIN: Are we going to schedule a work session in January? It might be a good idea with us new people up here.
MR. HESTER: I think it would be a good idea. Maybe we can get the information on other items that we want to discuss at that time.

I'm happy to have called Walkertown my home for about 28 years. What I'm here today for is I'm in the process of opening a hair salon and it's going to be – I'm sorry, I'm a little nervous – I've been doing hair about eleven or twelve years and what I want to introduce to, you know, with Walkertown growing, and, you know, people moving in, a multi-culture hair salon. I'm experienced with all kind of ethnic races and all and what I want to do today is ask the development division for a little boost to start my business and what I'm asking for is \$700.

MAYOR: Okay. What you need to go through is an application through the council office – the town office – so if you would go by there, that would be the best place to start on that. The council does not handle that in session. That would have to have an application first and then they would deal that in either the work session or at a public session – one or the other. She will be back in January to discuss more with you but she did want you to know that.
